BCAC has corresponded with the offices of the Prime Minister and the Premier to ensure the unique needs of our industry and our Province are not overlooked.

Working closely with Tourism Industry Association of British Columbia and British Columbia Economic Development Association to position for joint approach to recovery.



BCAC Response to COVID-19

Financially:

- BCAC is funded through memberships, revenue from our events and the generous support of our Industry.
- As we will be unable to hold our two signature events this year (Silver Wings and Spring Conference) and we have, understandably, lost some sponsorship funds we know that 2020/2021 will be lean years for our association.
- In March, we made the difficult decision to lay off our Executive Director and parttime web content manager. Dave has been volunteering full-time to support the Council.
- With careful management of existing funds we have been able to pay Dave \$1000 for each of the months of June and July.
- So far, we are ahead of our worst case scenario budget.
- The sustainability of our organization requires a full-time Executive Director. We have some work to do!
